THIS IS A NOTICE OF A 5-DAY PUBLIC HEARING AND A COMMENT PERIOD FOR AN AMENDMENT TO THE CONSOLIDATED PLAN AND FY 2020-2021 ANNUAL ACTION PLAN.

THE CITY OF POMONA IS AMENDING ITS CONSOLIDATED PLAN AND FY 2020-2021 ANNUAL ACTION PLAN TO APPROPRIATE AND REALLOCATE COMMUNITY DEVELOPMENT BLOCK GRANT CORONA VIRUS (CDBG-CV) AND EMERGENCY SOLUTIONS GRANT CORONA VIRUS (ESG-CV) PROGRAM FUNDS

This public hearing will appropriate additional funds based on actual expenditures and unexpended balances from prior year's projects and will re-allocate funds in the current year to other eligible activities.
