A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING WITH THE POMONA MID-MANAGEMENT / CONFIDENTIAL EMPLOYEES' ASSOCIATION AND AMENDING THE PUBLIC WORKS DEPARTMENT AUTHORIZED STAFFING LEVELS FOR THE FISCAL YEAR 2021-22 OPERATING BUDGET TO RECLASSIFY ONE SENIOR MANAGEMENT ANALYST POSITION TO THE NEW CLASSIFICATION OF PUBLIC WORKS FISCAL AND PROJECT MANAGER

**WHEREAS,** the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

WHEREAS, on September 16, 2019 the City Council adopted Resolution No. 2019-137 adopting the 2019-2021 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona Mid-Management/Confidential Employees' Association (PMMCEA), which also established a Roster of PMMCEA Classifications;

**WHEREAS**, the City Council has subsequently amended certain provisions of the MOU by resolution numbers 2019-200 and 2020-109;

**WHEREAS,** on June 7, 2021, the City Council adopted Resolution 2021-69 adopting the City of Pomona Operating Budget, which included authorized staffing levels; and

**WHEREAS,** in order to meet department staffing needs, the City Council desires to amend the authorized staffing levels and Appendix B of the aforementioned MOU by the actions provided herein;

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1**. That the City Council hereby authorizes an amendment to Appendix B of the PMMCEA MOU by adding the classification indicated below:
