

RESOLUTION NO. 2021-112

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING A SYSTEM OF PREFERENTIAL PERMIT PARKING ON SPECIFIED STREETS NEAR WESTERN UNIVERSITY OF HEALTH SCIENCES IN THE DOWNTOWN AREA OF THE CITY OF POMONA, PURSUANT TO VEHICLE CODE SECTION 22507**

**WHEREAS**, California Vehicle Code Section 22507 allows the City of Pomona to provide a system of on-street preferential permit parking for designated groups; and

**WHEREAS**, there is an identified need for student, faculty, staff, and guest parking for Western University of Health Science (“University”) in and around the University Campus in the City of Pomona; and

**WHEREAS**, the allocation of on-street parking to designated groups through a system of preferential permit parking will not cause an adverse parking problem or impact on residents or merchants in the area of the preferential permit parking.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The foregoing recitals are true and correct.

**SECTION 2.** The City Council hereby approves a system of preferential permit parking for the group of persons identified as Western University of Health Sciences students, faculty, staff and guest for the parking of vehicles from Monday through Friday, inclusive, during the hours of 7:00 a.m. to 7:00 p.m. only in the parking spaces identified as follows in the downtown area of the City of Pomona for the purpose of parking passenger vehicles (cumulatively, the “Preferred Permit Parking Spaces”). :

73	North and South Side of First Street between Palomares Street and Eleanor Street
86	North and South Side of Third Street between Gibbs Street and Eleanor Street
30	North and South Side of First Street just west of Palomares Street
24	North Side of Fourth Street between Gibbs Street and Eleanor Street
11	East and West Side of Gibbs Street between Third Street and Fourth Street
8	East and West Side of Elm Street between Third Street and Fourth Street
18	East and West Side of Palomares Street between First Street and Third Street
2	West Side of Palomares Street between Third Street and Fourth Street
4	East Side of Linden Street between Third Street and Fourth Street

The Preferred Permit Parking Spaces are specifically identified on Exhibit “A” attached to this Resolution.

**SECTION 3.** University shall provide users of the Preferred Permit Parking Spaces with permits to be displayed from the rear-view mirror of the parked vehicle. Vehicles parked in the Preferred Permit Parking Spaces must display a permit issued by the University specifically for marked or signed to identify the Preferred Permit Parking Spaces are mostly allocated to areas adjacent to existing parking lots, and not adjacent to residences or business uses.

**SECTION 4.** The City Council finds that the use of the designated parking spaces for Preferred Permit Parking Spaces will not adversely impact parking conditions for residents and merchants in the area. The Preferred Parking Spaces are mostly allocated to areas adjacent to existing parking lots, and not adjacent to residences or business uses.

**SECTION 5.** The Officers of the City are hereby authorized and directed, jointly and severally, to do any and all things to execute and deliver any and all documents which they deem necessary or advisable in order to carry out, give effect to and comply with the terms and intent of this resolution.

**SECTION 6.** This resolution shall take effect immediately upon its adoption.

City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
