to continue the item to the following regularly scheduled meeting pending applicant revisions to the proposed artwork and resubmittal to the Planning Division.

7-26-21 Cultural Arts Commission Citizens Advisory Committee did not recommend approval of the revised Conceptual Design Plan (PUBART 16327-2021) and motioned to continue the item pending a resubmit to include three separate designs to the Planning Division.

#### <u>Citizens Advisory Committee Evaluation Criteria</u>

Per Ordinance No. 4151 - Public Art and the Art in Public Places Manual. The Citizens Advisory Committee is tasked with evaluating the following:

- a. Artist's experience in the creation of works of art on display, and artist's willingness to engage in the spatial and cultural context of their surroundings in the creation of the work of art.
- b. Documentation provided is of sufficient descriptive clarity to indicate the nature of the proposed Public Art.
- c. Budget adequately captures the 1% equivalent value of the Public Art.
- d. Proposed location is compatible with adjacent parcels, building, and existing neighborhood.
- e. Proposed art will be placed in an area open and freely available to the general public.

#### **Committee Review**

On July 26, 2021, the Citizens Advisory Committee reviewed the revised Conceptual Design Plan during its regularly scheduled meeting (Attachment 1). The Committee motioned to continue the item pending artist resubmittal and provided the following feedback:

- 1. Remove the existing body of water and ship.
- 2. Revise the existing Goddess of Pomona to be more prominent.
- 3. Revise the mural to include imagery on a larger scale.
- 4. Provide three design concepts for consideration.

#### **Artist Revisions**

On September 9, 2021, the artist, David Holley, met with members of the Committee on the project site to discuss potential themes for the proposed mural. Committee members Batts, Judah, and Lucas, expressed to Holley that the Committee's role was not to inhibit the artistic process and that the artwork should reflect the work of the artist, with consideration to the cultural context of the surrounding community. The committee members encouraged the

artist to explore varying themes noting that not all three proposals needed to contain a Pomona landmark.

From the provided feedback from Committee members, the artist submitted three conceptual designs and three project narratives for consideration (Attachment 2).
