## **RESOLUTION NO. 2021-133**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING AN EASEMENT AGREEMENT WITH WALNUT VALLEY WATER DISTRICT, AND THE SPADRA BASIN GROUNDWATER SUSTAINABILITY AGENCY WHICH IS NECESSARY FOR CONSTRUCTION OF A GROUNDWATER MONITORING WELL AND IMPLEMENTATION OF THE SPADRA BASIN GROUNDWATER SUSTAINABILITY PLAN

WHEREAS, the City of Pomona (City) overlies the Spadra Basin and owns various properties in that area;

**WHEREAS**, Spadra Basin Ground Water Sustainability Agency (Spadra Basin GSA) is a groundwater sustainability agency formed under the Sustainable Groundwater Management Act of 2018;

**WHEREAS**, the City and Walnut Valley Water District (WVWD) are the sole members of the Spadra Basin GSA and each produce water from the Spadra Basin and are interested in ensuring the long-term sustainability of the Spadra Basin;

**WHEREAS**, the Spadra Basin GSA desires to obtain robust data on groundwater by constructing a new groundwater monitoring well within the Basin, so the Spadra Basin can be effectively managed; and

**WHEREAS**, the City Council is interested in ensuring the long-term sustainability of the Spadra Basin by: granting a temporary easement upon real estate of the City to WVWD for the constructing a new groundwater monitoring well; and, granting a permanent easement to the Spadra Basin GSA for continued maintenance and operation of the new groundwater monitoring well.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby approves an Easement Agreement with WVWD and the Spadra Basin GSA which is necessary for the constructing a new groundwater monitoring well and implementation of the Spadra Basin Groundwater Sustainability Plan.

<u>SECTION 2</u>. That the City Manager is hereby authorized to execute the Easement Agreement, Exhibit 1, on behalf of the City.

**<u>SECTION</u> 4.** That the City Clerk shall attest and certify to the passage and adoption of this resolution, and it shall become effective immediately upon its approval.
