RESOLUTION NO. 2021-130– A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2021-22 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY APPROPRIATING \$278,900 OF MEASURE W (SAFE CLEAN WATER PROGRAM) FUND RESERVES TO THE “PEDLEY SPREADING GROUNDS - POND ENHANCEMENTS,” PROJECT NO. 428-2590-XXXXX-81058

WHEREAS, in November 2018, Measure W (now Safe Clean Water Program) was approved by Los Angeles County voters to improve water quality in a manner that achieves additional benefits such as increasing water supply and investing in the health and well-being of Los Angeles County communities;

WHEREAS, the City Council has prescribed the authority by Charter of the City of Pomona to adopt and amend the CIP budgets;

WHEREAS, on January 4, 2021, City Council adopted Resolution No. 2021-03 and Resolution No. 2021-04 to receive and appropriate funds from the LA County Safe Clean Water Program (Measure W) per the terms and conditions of the Measure W funding agreement, and created the CIP project “Pedley Spreading Grounds – Pond Enhancements,” Project No. 428-2590-XXXXX-81058; and

WHEREAS, the City Council desires to amend the FY 2021-22 CIP budget by appropriating \$278,900 from Los Angeles County Flood Control District’s Safe Clean Water-Regional Program (Measure W Tax Revenue) to the “Pedley Spreading Grounds – Pond Enhancements,” Project No. 428-2590-XXXXX-81058.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council amends the FY 2021-22 CIP budget by appropriating \$278,900 of Measure W (Safe Clean Water Program) Funds to the “Pedley Spreading Grounds – Pond Enhancements,” Project No. 428-2590-XXXXX-81058 (428-2590-66196-81058, 142-2590-89987-81058 and 428-2590-80708-81058), leaving the project partially funded.

SECTION 2. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
