A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ACCEPTING THE STATE OF CALIFORNIA OFFICE OF TRAFFIC SAFETY (OTS) TRAFFIC RECORDS IMPROVEMENT GRANT IN THE AMOUNT OF \$25,000 AND AMENDING THE FY 2021-22 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS IN THE AMOUNT OF \$25,000

WHEREAS, the State of California's Office of Traffic Safety (OTS) has awarded a Traffic Records Improvement Grant to the City of Pomona to implement a timely and efficient upload of collision report data and documents. The grant period begins October 1, 2021, and continues through September 30, 2022; and

WHEREAS, the total amount of \$25,000 will be used to implement an interface between the Pomona Police Department's traffic collision database and the Statewide Integrated Traffic Records System (SWITRS);

WHEREAS, the authority to accept the Traffic Records Improvement Grant and amend the current revenue and operating budgets to appropriate the OTS grant funds to be received is vested with the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

- **SECTION 1.** The City Council hereby accepts the Traffic Records Improvement Grant award of \$25,000 and agrees to the terms and conditions of the grant agreement.
- **SECTION 2.** The City Council hereby amends the FY 2021-22 Police Department's Miscellaneous Grant Fund budget revenue estimates in the amount of \$25,000 (215-2014-40875-58748), with a corresponding appropriation of \$25,000 (215-2090-66193-58748).
- **SECTION 3.** The City Manager, or designee, is hereby authorized to enter into the grant agreement on behalf of the City.
- **SECTION 4.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall be effective immediately upon its approval.
