MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Preciado announced that DayOne Pomona would be hosting a movie night. Community garden organizers have been hosting a farmer's market every Wednesday. Project Hope will host their Hope Fest on Saturday, October 2 at Tony Cerda Park.

Vice Mayor Lustro announced that the upcoming Westmont Community Meeting would be postponed until mid-October.

Councilmember Ontiveros-Cole attended a soft opening for the Lion's Den, a new gym in Pomona.

Councilmember Garcia announced Story time every Wednesday outside the Pomona Library, a "Juice and Paint" Event also at the library and Brown Memorial Temple hosting Good Shepard Day event helping the homeless community. She also asked the community for donations of new clothes for teenage boys for the EIS center at the Fairplex.

Councilmember Nolte reported that he participated in PEOC's Caminata por el respeto event where he walked from the day laborer center in Rancho Cucamonga to Pomona's day laborer center in support of the immigrant community.

Councilmember Torres thanked veterans for their service. He thanked District 6 residents who attended the meeting regarding Carvana. He attended the Contract Cities Conference and spoke about SB 9 and the negative impact it will have on Pomona now that the governor has signed it. He reported that he would be hosting with Blue Shield a flu shot event on November 6 at Palomares Park.

Mayor Sandoval reminded residents about Pomona Connect, which offers a range of resources. He reported that the Fairplex is hosting a Bite Size Fair on weekends and he encouraged residents to attend.

Gloria Almanza spoke about a recent successful event called Rebellion at the Art Walk and other artists including herself that were honored for this event.

Darrell Kruse spoke about his concern with the process on how cannabis businesses were now being allowed in the City and his frustration with how cannabis has been viewed and handled in the city in the past specifically in regards to medical cannabis.

Ion Puschila thanked the staff and council for paving the streets and beautification of the City of Pomona Page 4

City. He thanked the Mayor for helping with the historical preservation. He thanked the council for their work with literacy programs. He expressed concern with Ginna Escobar being appointed to a commission.

Cynthia Marino urged the council to reconsider Ginna Escobar's appointment to the Phillips Ranch committee.

Kendall Fraves from Just Us 4 youth spoke about the work their organization has been doing in the community.

Jacqueline Elizalde congratulated the two new commissioners appointed by Councilmember Torres and stated that people should speak positively about those who volunteer their time for appointed positions.

Hevelyn Neely, founder of Greener Stems, spoke about her organization's work to support those that homeschool and their support of clean living.

I would also like to congratulate the appointment of Councilman Torres' youth commissioner- Mr. Jason Ham, of District 5. Thank you for your time. Looking forward to seeing you all soon.

DEBBIE MOLITOR – This is in regards to the appointment of Ginna Escobar to the Phillips Ranch Oversight Committee. I am going to share what many of my fellow neighbors are also sharing with one additional component, which will speak to Ginna's character and the lack of trust I and many neighbors feel about Ginna. This must have been 10 plus years now, when Ginna had her dance studio in the Phillips Ranch shopping center. Her studio was fairly new and I went in to buy a gift card for my best friend. Her parents were at the front desk and ran my credit card three times for a \$100.00 gift card. I was charged \$300.00. It was a mistake for sure and I didn't notice for a couple of months. When I contacted Ginna about it, she said to send her all the info, which I did and I still have not heard back from her...I followed up with her for a while, and never got a response.

Ginna Escobar violated the Brown Act and should not be allowed to serve on this oversight committee. In 2018 it was brought to council's attention that Greentech performed landscaping work on then, Councilmember Ginna Escobar's property. There are images that actually captured the landscapers performing the work during city time. The landscapers admitted to being pulled from doing city work to do work at her property. City minutes from November 9th, 2018 attest to this. Just these two actions alone should be enough to question whether she should be allowed to serve the people of Phillips Ranch. The last election results should speak volumes!

COOK FAMILY – I respectfully request Mayor Sandoval and our City Council members to give great attention to the addition of Ginna Escobar to the committee of our current access committee's program. I feel it is totally inappropriate to honor this idea. I, as well as many, many Ranch citizens, feel it tremendously wrong. It is so unwise to have any kind of involvement with her. Many of us are aware of her unethical procedures, serving HERSELF at the expense of our city's budget. Our City officials are well aware of what I refer to. Thank you for your consideration.

AMALIA GARCIA – I am writing to you regarding the recent appointment by Robert S. Torres, of Ginna Escobar as a representative for the Phillip's Ranch Assessment. As a resident and homeowner of district 5, I do not approve or want Ginna Escobar as a representative of the Phillip's Ranch Assessment or any other government or community seat. Due to the the fact that when she was a council member she abused her position and power. She used the landscaping contractor for D5 at the time to do the lawn maintenance at the residence she occupied. The landscaping contractor is employed and paid with the assessment all D5 homeowners pay to maintain the 200+ acres of green space, not perform work at a private residence. She was basically stealing our money and using it for her personal benefit. She didn't apologize or repay the money. Also, while elections were taking place, she allowed ex-council member and now registered sex offender Rubio Gonzalez to register on www.nextdoor.com, neighborhood app as a person residing at her address so that he could communicate with D5 residents and tell

us all off. He made some uncivilized, reckless comments and accusations and maybe even a threat. Having experienced and seen the above mentioned situations, I ask for you to negate this appointment immediately. Her previous actions speak of her character and lack of integrity. She has no credibility with me. She is not a public servant! Thank you for your time.

PRISCILLA KANNAPEL – My name is Priscilla Kannapel and I am a resident of Pomona. I had a legal yard sale this last week end, in spite of the oppressive heat both buyers and sellers experienced. I am hopeful, something can be done to address, what as we sellers can legally do when the heat is excessive, such as last weekend. But, I have another concern about the actual months in which we are allowed to have legal yard sales. Currently, we are holding the yard sales in March, June, September and December, which use to coincide with the "traditional school calendar," this is no longer the case. Now, school starts in August and ends in May, which effects when families take summer vacations and in turn, effects our potential customers, especially our June date. Also, having to get ready for a yard sale in December when things are frantic enough with 2 main holidays, is another impact on both sellers and buyers. I hope the City Council and Legal Council, will consider amending the yard sale city code to the following months for future yard sale dates in Pomona, February, May, August, and November. Thank you.

IDA WEIL – My name is Ida Weil and I am a resident of Pomona. Having had a legal yard sale this last weekend, in spite of the "excessive heat warnings' that had been issued by the Weather Service for Wednesday thru Sunday of that week, my neighbor and I went ahead with our yard sale, because that was the only option we had for a legal yard sale in the City of Pomona. We realized that we were putting our health at risk and I'm sorry to say, those of our customers. For this reason, I would like the City Council to consider an additional exception to City Code Article XII, Section 39-753 – Time Limits of our yard sales. We make an exception for rain and let it be rescheduled for the following weekend, I would like the same exception to apply when an "excessive heat warning" is issued by the Weather Service for our legal yard sale dates. This would have given us a "legal" option to use the following weekend. To hold a yard sale in the extreme heat we experienced last weekend, is dangerous for both sellers and buyers. Thank you.

CYNTHIA MARINO – Good Evening, Mayor Sandoval and Council.

I would like to start by thanking most of you for your hard work, time, dedication, and well intentions for the city of Pomona! Unfortunately, what I have to say is not very pleasant, in fact quite the contrary. I am completely opposed to Councilmember Robert Torres' appointee, (Ginna E. Escobar) to District 5's, Oversight Committee. The oversight committee was created due to the Ex-Councilmember's negligence during her 8 years. On September 1st, one of Councilmember Torres' post started circulating social media. The post is a picture of him and Ginna Escobar in front of city hall and it reads, "I'm proud to appointment former Councilwoman Ginna Escobar as my representative on the Phillips Ranch Assessment District. She is a homeowner and businesswoman with a lot of great city experience. I'm thankful she is taking time out of her busy day to help keep Phillips Ranch looking beautiful." I urge the council to please reconsider Robert Torres' appointee, and not allow this to happen. Phillips Ranch residents have lost confidence in our city government. Our city council needs to take steps to repair this lost confidence,

instead of giving another reason to distrust our city government. Mayor Sandoval, is it possible to put this item on the consent calendar and have council vote on it? The following is a Fact not my opinion: Ginna Escobar was in direct violation of the Brown Act and should not be allowed to serve on this oversight committee. In 2018, through Public Comment at a City Council Meeting (that Robert Torres was present) it was brought to council's attention that Greentech (Phillips Ranch former landscaper) was performing landscaping work on former Councilmember Ginna Escobar's property. Copies of images capturing the landscapers performing this work during city time were provided to the City Clerk. Also, the landscapers admitted to being pulled from doing city work to do work at her property. This is public record found on the city minutes from November 9th, 2018. Robert Torres is not looking out for the best interest of Phillips Ranch.

To the residents of Pomona, in this case specifically Phillips Ranch residents I would like to encourage you to:

- 1. Pay attention to what's going on in our city.
- 2. Remember, there is a reason why we voted Former Councilmember Ginna Escobar out. What was your reason? This was definitely one of my many reasons why Ginna Escobar did not have my vote!

Knowing about the Brown Act Violation and Appointing Ginna Escobar to sit on the Phillips Ranch Oversight Committee is a slap on our face and ill willed on Councilmember Torres' part. What is your message councilmember Torres? Don't you care about the Brown Act or Ginna Escobar's violations? Don't Answer that, you already have Loud and Clear! Thank you, council for listening!

DISCUSSION ITEM NO. 29 (Approval of the City of Pomona's Expenditure Plan for the Coronavirus State and Local Fiscal Recovery American Rescue Plan (ARP) Funds Allocated from the United States Federal Government Department of Treasury

JOHN CLIFFORD - There seems to be some concern about the disbursement plan presented for the Federal ARP funding to the city. The proposal as I understand it, allows the elected councilmembers from each of the districts, and the mayor representing the city as a whole, to set priorities and recommend projects for a portion of this funding (\$6 million of the over \$43 million appropriated). The majority of the funding is to be spent in accordance with projects defined by city staff and council as important for the goals of the funding. I've read community comments that this is nothing more than pork for the council. That it will allow them to curry political favor of supporters. At least this funding has to meet the requirements that ALL the funding be used per the criteria of the funding guidelines. If the funding is not prioritized and allocated by the councilmembers, who does it? That would be city staff. I don't know about you, but I've never voted for a single city staff person. Senior city staff, city manager, assistant city managers, city clerk, etc., do not reside in our city. I maintain that ELECTED councilmembers have a little better handle on the needs of our neighborhoods. The funding is here. The question is WHO will determine how it's spent? The vote tonight is to entrust the decision making to ELECTED resident council/mayor, or to NON-ELECTED, non-resident, city staff. City staff are good, professionals who have a singular view of the city from the standpoint of operations and efficiencies, for which they do a pretty good job. Community members have a view of what WE feel is needed. Tonight you will decide. I tend to favor the people that I've voted to represent us. Thank you.
