

**RESOLUTION NO. 2021-136**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA AMENDING THE CITY OF POMONA'S SALARY SCHEDULE FOR FISCAL YEAR 2021-22 TO MEET THE CALIFORNIA CODE OF REGULATIONS TITLE 2, SECTIONS 570.5 AND 571 TO REFLECT A 3% GENERAL SALARY INCREASE FOR SWORN CLASSIFICATIONS IN THE POMONA POLICE OFFICERS' ASSOCIATION MEMORANDUM OF UNDERSTANDING**

**WHEREAS**, the City Council has the authority to create, classify and design salary scales/ranges for all City of Pomona employee positions;

**WHEREAS**, California Code of Regulations (CCR) Title 2, Section 570.5 and amendment to CCR Section 571 requires a consolidated Salary Schedule that is publically available showing all City classifications and salary ranges;

**WHEREAS**, the City Council wishes to meet the requirements of these regulations by adopting a Salary Schedule, which sets forth the salary scales/ranges for all City of Pomona employee classifications; and

**WHEREAS**, the City Council adopted Resolution 2021-75 adopting the Citywide Salary Schedule for Fiscal Year 2021-22, which sets forth the salary scales/ranges for all City of Pomona employee classifications;

**WHEREAS**, the City Council has subsequently amended certain salaries of the Salary Schedule by resolution number 2021-127; and

**WHEREAS**, Exhibit A includes the Citywide Salary Schedule reflecting a 3% General Increase to the salaries of Police Officer, Police Corporal, Police Investigator, and Police Sergeant classifications.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby adopts the Salary Schedule for all City of Pomona employee classifications as set forth in the attached Exhibit A to reflect a 3% General Increase to Police Officer, Police Corporal, Police Investigator, and Police Sergeant classifications.

**SECTION 2.** The action approved herein shall become retroactive effective October 1, 2021.

**SECTION 3.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
