#### **NEW BUSINESS:**

5. DOWNTOWN POMONA OWNERS ASSOCIATION (DPOA) REQUEST TO UTILIZE ALL VPD DOWNTOWN LOTS WITH THE EXCEPTION OF THE LOTS LEASED TO WESTERN UNIVERSITY, THE DAUMIER AND THE HELIX FOR THE ANNUAL 2018 CHRISTMAS PARADE PARKING; AND THE CITY'S REQUEST TO UTILIZE OFFICER SHAUN DIAMOND PLAZA AND LOT 10 FOR THE HOLIDAY AT THE PLAZA EVENT; AND WAIVE ALL VPD PARKING FEES ON DECEMBER 8, 2018

Joaquin Wong provided a staff report regarding a request from the DPOA. He stated staff recommended to approve the DPOA's request to utilize all VPD Downtown lots (with the exception of the lots leased to Western University, the Daumier and the Helix) for the Annual Christmas Parade and parking; and the City to utilize Officer Shaun Diamond Plaza and Lot 10 for the Holiday at the Plaza event; and waive all VPD parking fees for the entire day on December 8, 2018 and to find that the event will benefit the VPD by increasing future parking patronage due to guests attending the event and becoming aware of available VPD public parking.

Motion by Vice Chair Schowalter, seconded by Commissioner Alas, carried by a unanimous vote of the members present (6-0-0-1), Commissioner Diaz absent, approving the DPOA's request to utilize all VPD Downtown Lots and the finding that the event will benefit the VPD.
