Chair Camacho- Informed Commissioner that Pomona Beautification is done by projects that are submitted by community members. The project request is submitted and reviewed by the committee, which is assigned to groups that do the clean-up on Pomona Beautification day.

Commissioner Alvarez- Are weeds something that get cleaned up on Pomona Beautification day?

Chair Camacho- Yes, weeds, stone work and painted road curbs. Pomona Beautification is project-based.

Commissioner Alvarez- My communication is with my Council person and what she wants to focus on with District Four. Our responsibility as a commission is being a liaison to constituents and our council.

Chair Camacho- Would like an update when the Youth Commission is coming back.
