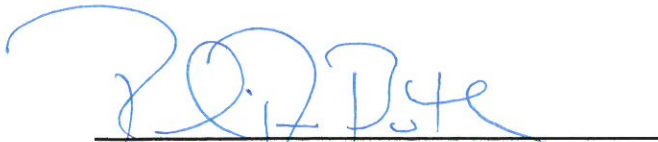

ADJOURNMENT

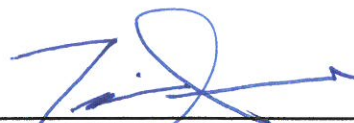
The Special City Council meeting was adjourned at 9:11 p.m.
