General Priorities (in no particular order of importance)

1. Economic Development

Includes: business retention and attraction; community development; housing development; City image and marketing.

Functional Areas: Economic Development, Development Services, Public Works (permit processing)

2. Clean and Safe Community

Includes: public safety, community programming, maintenance, housing services

Functional Areas: Police, Fire, Animal Control, Code Compliance, Community Services, Library, Public Works (solid waste and maintenance functions); Water Resources (maintenance functions), Housing Services, Housing Authority, homeless services

3. Infrastructure

Includes: construction and repair of City infrastructure such as streets, sidewalks, storm drains, and water systems

Functional Areas: Public Works (Engineering, infrastructure maintenance and repairs); Water Resources

4. Fiscal and Operational Responsibility

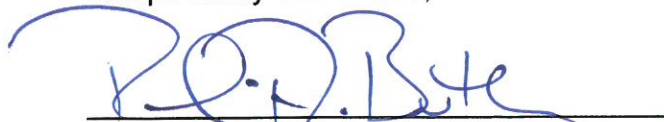
Includes: financial, any other operational goals that do not fit within other priorities

Functional Areas: City Administration, City Clerk, City Attorney, Finance, Human Resources, Information Technology
