### MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Preciado spoke on the Pomona Choice program and reported that there will be a town hall meeting on Thursday, September 24. He also spoke about a tragic accident over the weekend and reminded all not to drink and drive.

Councilmember Garcia thanked God's Pantry for delivering food to the Mosaic Gardens apartments over the weekend and thanked Councilmember Preciado for facilitating God's Pantry providing food on Tuesdays and Thursdays since the pandemic began. She advised that on Friday, September 25 at Ganesha High School there would be a food drive sponsored by Carlos Goytia of Three Valleys Municipal Water District. She spoke about the COVID action committee being available to help to those who reach out. Finally, she reminded everyone to complete their census form.

Councilmember Ontiveros-Cole reminded everyone to take advantage of the food distributions going on in the City if they are in need.

City Manager James Makshanoff had nothing to report.


### PUBLIC PARTICIPATION

Linda Matthews, Human Resources and Risk Management Director provided an overview on item 7-1.

City Attorney Carvalho gave the update on eviction moratoriums. She reported that several state and federal protections exist strictly for COVID related evictions and tenants could choose which law would best protect them against eviction in court. The City's only option at this point is to defer to these other protections until the State's protections expire in February 2021. She advised that her office would continue to monitor any changes in state and federal regulations and look to other agencies for plans that might help Pomona.

Councilmembers made comments on this item.

Benita DeFrank, Neighborhood Services Director, spoke about the outreach efforts by City staff to let the community know there are resources to help fight COVID related evictions.

## SEPTEMBER 21, 2020 REGULAR CITY COUNCIL MEETING PUBLIC COMMENTS

#### PUBLIC COMMENT

PASTOR AARON LEVY FROM THE ABUNDANT LIVING FAMILY CHURCH – In response to the devastation our nation has suffered due to continued racial division and senseless violence, Mayor Tim Sandoval has formed the African American Advisory Alliance (4As) comprised of advocates, artist, educators, faith-based leaders, and youth in the City of Pomona. Our aim is to take immediate action for racial reconciliation, equality and justice; and to create strategic plans for long-term opportunities and advancement for our Black residents in Pomona. Current areas of focus include but are not limited to (1) Support of Black Owned and Operated Businesses, (2) Support of strategic programming and functionality of Non-Profit Organizations for the Black Community, (3) Investment in Black Visual and Performing Arts, (4) Equity & Accountability in Community & Policy, and (5) Collective Input and Action from our Community. A survey will be sent out soon to gather input from Pomona residents to aid our strategic plan for reconciliation and equity.

JULIE MESTAS – I was happy to hear that the DUI Checkpoints have returned. Perhaps if one had been conducted last Thursday night, a woman's life would have been spared. Instead of complaining about the Police Department, perhaps we need to allow them to enforce the consequences for breaking the law. Your continued support of the Pomona Police Department is appreciated and encouraged.

PATRICIA NEWTON – I expect the members of the Pomona City Council to show leadership in supporting and giving authority to the Pomona Police Department. As a property owner, business owner and landlord, I am tired of not being represented. A seasoned tenant was lost a few years ago due to the Council's awarding of a new contract to an outside organization. My new tenant is discouraged having to continuously deal with the vagrants. They are destroying the perimeter of the property, breaking in and stealing personal items. If they move out, it will be the fault of your inability to properly control the streets of Pomona. If the police budget needs to be increased to provide additional services, then I encourage you to find a way.

RIKKI FINE – Pomona residents should not have to tolerate vagrants in our community. The homeless need to be directed to the Shelter or advised to move on. My daughter cannot play in our yard. My two neighboring houses have found people sleeping on their front porches. Someone even trespassed in my neighbor's yard and stole his personal property. What I think could be drug transactions are being conducted in the street. My landlord has tried to assist, but there is only so much she can do. Please give the members of the Pomona Police Department the tools and authority they need to clean up the streets. I love my home and do not wish to move, but this situation has become intolerable.

ELIZABETH BROOKS - There is a difference between asking tenants to move and evicting them. Due to Covid-19 landlords are currently not able to evict a tenant due to non-payment of rent, even if they ask them to move. I have a pending eviction due to the tenants creating a nuisance, and since the tenants have not been arrested for gun or drug possession, the request failed to even be heard in court. The fact that the neighbors are being harassed and feel threatened carried no merit with the courts. It is important that you do not make eviction rules more restrictive, as it is making it difficult for us to protect our tenants. The majority of residential tenants are paying their rent and there is no need to make additional changes. There is rental assistance available for those seeking help. Also, why are laws only for those who choose to follow them? Residential rental properties in Pomona require business licenses. Local restaurants are required to have licenses and are subject to health inspections. Businesses have to obtain approved city licenses before they are allowed to open up. It should not be a surprise when street vendors are removed by authorities for not complying with City requirements. The City is beginning to look like a flea market. I understand surrounding cities are starting to enforce the rules concerning non-licensed vendors, and I encourage the Pomona City Council to do the same.

DARRELL KRUSE – On April 3, 2006 we asked , I quote "We look forward to attending all hearings regarding this matter and ask that you include us in your contact list for all hearings regarding regulating cannabis dispensaries in your city." We have been asking you to regulate this business since 2005. For us, not for anyone else. We knew this time would come, we stated , I quote "There are now 10 States that have laws allowing Cannabis Use for Medical purposes, it won't be long now." Where is my Cannabis business license. Your lying cheating useless good for nothing council staff had a duty to notify us before you considered the licensing of Cannabis businesses. When confronted with allowing our use or shutting down others, you properly chose excessive force at first. After repeated visits, requesting action against the unlicensed dispensaries operating, or giving me my license you chose to shut down the dispensaries. But your incompetent staff could not get them shut down. You allowed them to continue now for over 10 years. I stopped complaining when you agreed I had priority. Don't hate me like that Ignorant Mayor Norma Torres, fix this.

## CONSENT CALENDAR ITEM NO. 4 (EXTENSION OF CITYWIDE LANDSCAPING AND PARK AMENITY MAINTENANCE CONTRACT WITH MCE CORPORATION)

JACQUELINE ELIZALDE – As a member from Teamsters 1932, I'm disappointed. It has been almost four years later under your leadership and here we are, the outsourcing of Parks and Recreation to MCE has made its permanent mold in Pomona. I don't understand how a council could be so anti-union only to save our city a few hundred dollars. Jobs were lost, workers were displaced and let us ask ourselves, "As elected officials did our city save money by outsourcing to MCE off the backs of our working class?" Families can't enjoy public restrooms without stepping on filth, children are often greeted with trash, there are used condoms and needles everywhere. There is no place for families, and it has only got worse. This was NOT the case when we had our very own

staff hired and invested to do the job. There have been ZERO conversations about bringing these essential jobs back to Pomona. We need our city workers back who take pride in our city. Again, NOTHING was done in **2017**, **2018**, **2019** and still nothing has been done today, **2020**. This isn't a new agenda item and let the record speak for itself-outsourcing has cost our city more!

## <u>DISCUSSION CALENDAR ITEM NO. 7 (SUSPENSION OF LATE FEES AND GENERAL UPDATE ON COVID-19)</u>

**KEITH BOOKER** – I live next door to the tenants of a pending eviction. I work and have not been able to sleep in months due to their night-time activities. When one was arrested for domestic violence, we were all harassed the next day for contacting the police. We are done. I resent being woken up by people running from the back of my apartment complex to cars waiting in the middle of the street all hours of the night. Two weeks ago I came home and had to hose down my front door area as it was apparent that someone had relieved themselves all over my security-screen door. These tenants have trapped me in my car in an attempt to intimidate me, and I now have Pomona PD on speed-dial. Mayor Sandoval, do you really want to receive more calls of complaint? Please let the courts and property manager's deal with tenants and do not make evictions harder to complete. My health and peace of mind depend on it.
