STAFF COMMUNICATION

Staff provided the following Community Services updates:

- This summer, there were four Movies in the Park held at Philadelphia Park, Ganesha Park, Jaycee Park, and Ralph Welch Park.
- Staff hosted the 3rd annual Heroes of Pomona Speech Contest awarding \$2,000 in scholarships.
- A variety of 1-2 week specialty camps were offered such as a water camp, art camp, sports camp, life skills, and a young writers camp.
- Seventy-four youth were provided the opportunity to participate in a weeklong overnight camp experience at Camp Oakes in Big Bear, CA.
- Six locations, one in each District, have re-opened for After School Recreation programming at Garfield, Westmont, Kiwanis, Ralph Welch Park, Philadelphia Park, and La Casita.
- Four community input meetings were held to obtain feedback for the Outdoor Equity Grants Program application.
- The Community Services' Instagram account now has 680 followers and the goal is to reach 1,000 followers by the end of this year.
- The fall/winter recreation guide is now available online.
- City Council authorized additional Recreation Coordinator positions. The After School Recreation Coordinator will begin August 13, 2021, the Senior Coordinator will begin August 27, 2021, and the Class & Collaboration Coordinator will begin in about 4

weeks.
