Senior Project Manager Joaquin Wong provided an update on the pay by phone system for the VPD pay stations.

Deputy City Manager provided on update on the potential sale of VPD lots two, six, and seven for various projects.

Commissioner Elizalde asked a question in regards to the location of Lot 26t.

Commissioner Elizalde stated she has no questions or comments.

Commissioner Garcia-Juarez stated he looks forward to serving on the VPD Commission.

Commissioner Luis Corcuera stated he is in search of relief for community members who have been impacted by Covid-19.

Deputy City Manager Kirk Pelser stated that the Mayor's Weekly Task Force meetings would be an ideal place to inquire about local relief efforts for community members.

Senior Project Manager Joaquin Wong stated that it is very difficult for the Vehicle Parking District to disperse public funds to issues not relating to parking.

Vice-Chair Sergio Diaz Luna provided a brief summary of previous situations where the Vehicle Parking District has provided free parking spaces to non-profit organizations.

Deputy City Manager Kirk Pelser stated the City Manager currently has the power to provide free VPD Lot access to organizations as long as it benefits the community.

Chair Joseph Mladinov III asked city staff to forward new VPD Commissioners documents in regards to VPD policy.

Commissioner Marcos Molina questioned the VPD by-laws in regards to preventing a potential commissioner from serving on any City of Pomona commission if said commissioner has been voted out of a commission.

City Clerk Rosalia Butler responded by stating that each commission has a different set of by-laws. City Clerk Rosalia Butler also stated that she would look into the VPD by-laws in order to address Commissioner Marcos Molina's question.

Chair Joseph Mladinov III stated he has been pleased with the attendance and participation of previous VPD Commissioners.

Commissioner Juan Carlos Garcia Juarez stated that changing the time and date of commission meeting is a possible solution for commissioners who are often late and or absent for meetings.

Commissioner Jacqueline Elizalde questioned if by-laws must go through the charter.

City Clerk Rosalia Butler stated that the charter provides the overall formations of commissions and that by-laws may be amended by 5-7 majority vote of the VPD Commission. City Clerk Rosalia Butler then provided a brief summary of VPD by-laws.

Deputy City Manager Kirk Pelser questioned if staff were to agendize any potential changes to the bylaws would that be enough cover to discuss at next month's meeting (March 2021) in order to undergo an action at the following month's meeting (April 2021).

City Clerk Rosalia Butler responded to Deputy City Manager Kirk Pelser by stating that it would be possible to agendize the by-laws in a staff report in order to adopted at a future VPD meeting.
