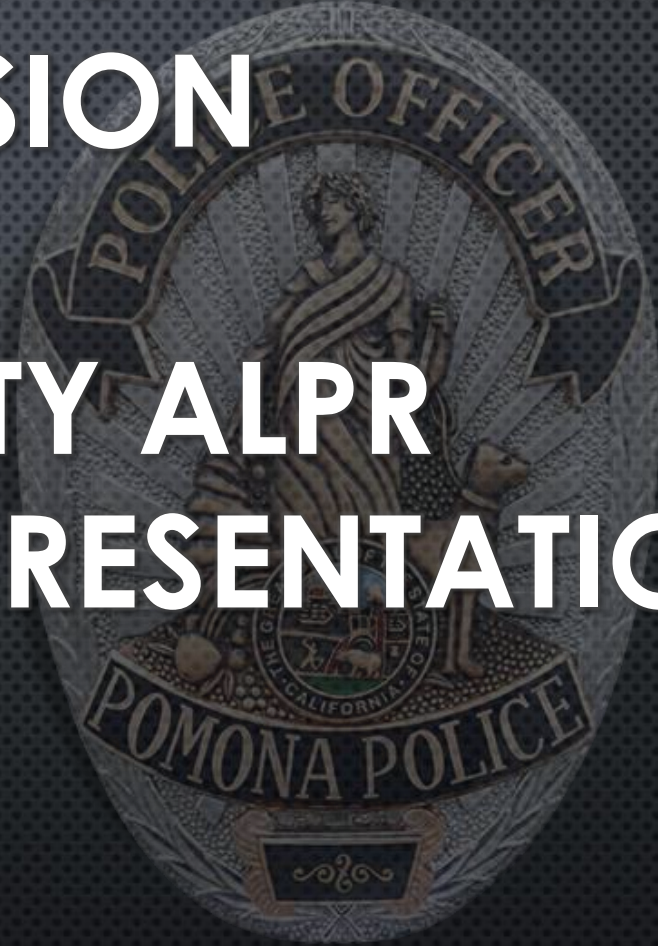
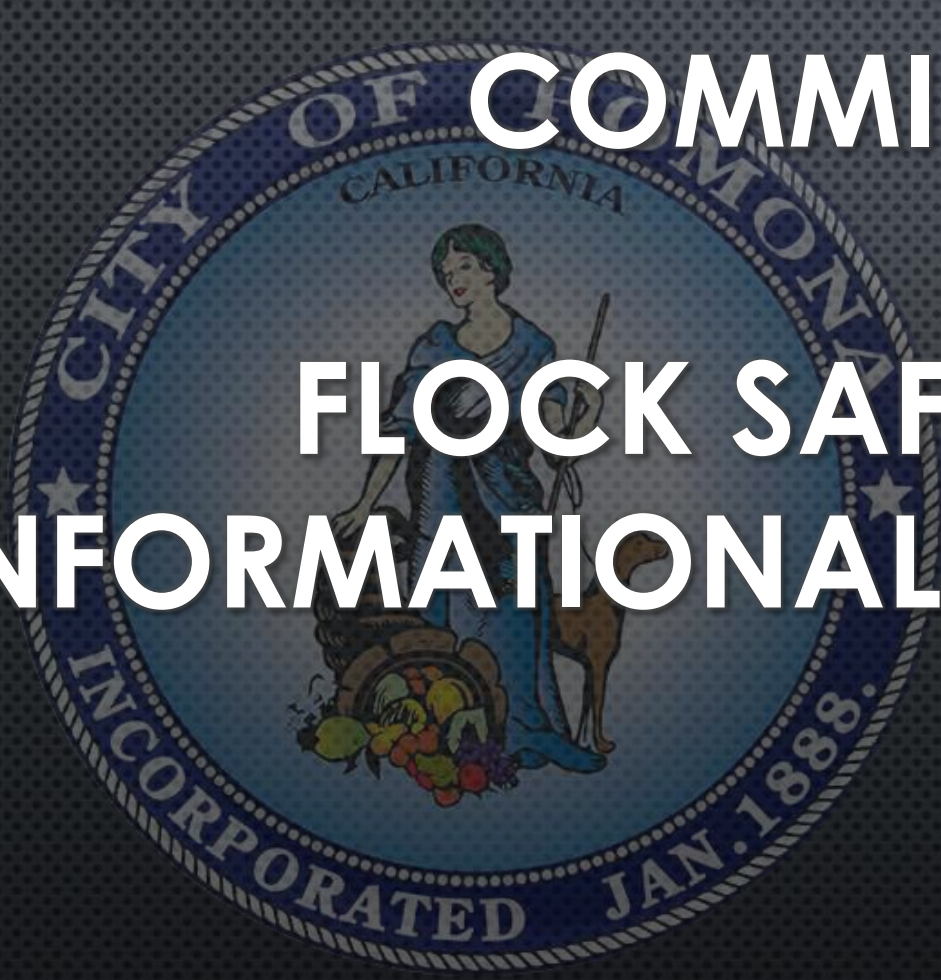

WHAT IS FLOCK ALPR?

FLOCK SAFETY PROVIDES AUTOMATED LICENSE PLATE RECOGNITION (ALPR) CAMERAS THAT CAPTURE VEHICLE DATA 24 HOURS A DAY, 7 DAYS A WEEK

- LAW ENFORCEMENT APPLICATIONS
 - REAL-TIME ALERTS
 - INVESTIGATIVE SEARCH TOOLS
 - STOLEN VEHICLE RECOVERY
- POMONA PD CONTRACT INFO
 - 69 FLOCK ALPR CAMERAS
 - LEASED SYSTEM

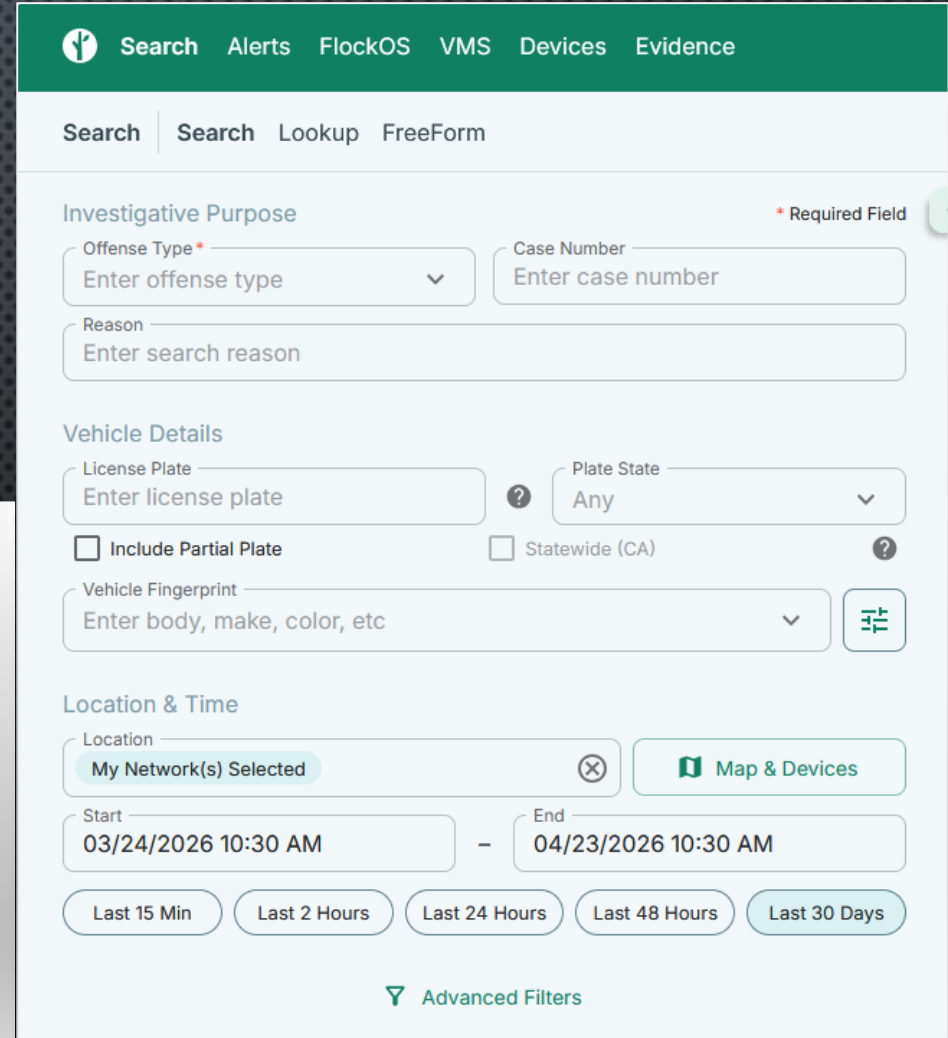


RIGHTS & SAFEGUARDS

DATA PRIVACY

- **WHAT IS ALLOWED & WHAT ISN'T**
 - **ONLY USED FOR PUBLIC SAFETY PURPOSES**
 - **NOT USED FOR MASS SURVEILLANCE OR TRACKING INDIVIDUALS**
- **HOW DATA IS COLLECTED AND MANAGED**
 - **DATA CAPTURED BY ALPR: PLATE IMAGES AND VEHICLE CHARACTERISTICS**
 - **DATA NOT COLLECTED BY ALPR: BIOMETRIC DATA OR DRIVER INFORMATION**





DATA PRIVACY (CONT.)

- DATA RETENTION – 30 DAYS
- AGENCY CONTROL OF ACCESS
- SAFEGUARDS THAT PROTECT DATA
 - RESTRICTED
 - SECURE
 - ACCOUNTABILITY
- Mitigating Misuse
 - Purpose Limitations
 - Activity Log
