SUBJECT: PUBLIC HEARING AND CONSIDERATION OF A RESOLUTION AUTHORIZING AND DIRECTING THE COUNTY OF LOS ANGELES AUDITOR-CONTROLLER TO INCLUDE DELINQUENT SOLID WASTE (TRASH) COLLECTION CHARGES AS A SPECIAL ASSESSMENT TO BE COLLECTED ON THE PROPERTY TAX ROLL FOR FISCAL YEAR 2026-27 AND RECORD A LIEN AGAINST SUCH DELINQUENT PARCELS OF PROPERTY AND AMENDING THE FISCAL YEAR 2026-27 OPERATING BUDGET TO INCREASE REVENUE ESTIMATES BY \$80,475

RECOMMENDATION:

It is recommended that the City Council take the following actions:

- 1) Conduct a Public Hearing, and after consideration of public testimony;
- 2) Adopt the following resolution:

RESOLUTION NO. 2026-41: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING AND DIRECTING THE COUNTY OF LOS ANGELES DEPARTMENT OF AUDITOR-CONTROLLER TO INCLUDE DELINQUENT SOLID WASTE (TRASH) COLLECTION CHARGES AS A SPECIAL ASSESSMENT TO BE COLLECTED ON THE PROPERTY TAX ROLL FOR FISCAL YEAR 2026-27, TO RECORD A LIEN AGAINST SUCH DELINQUENT PARCELS OF PROPERTY, AND TAKING OTHER ACTIONS RELATED THERETO AND AMENDING THE FISCAL YEAR 2026-27 OPERATING BUDGET TO INCREASE REVENUE ESTIMATES BY \$80,475 IN FD145 REFUSE ADMIN | CC2506 GENERAL OPERATIONS | REIMBURSEMENT; and

- 3) Approve the lien list of delinquent Solid Waste (Trash) collection accounts to be submitted

to the Los Angeles County Auditor-Controller (Controller) no later than August 10, 2026, to be included as a special assessment for the respective affected parcels on the County property tax rolls.

EXECUTIVE SUMMARY:

Approval of Resolution No. 2026-41 (Attachment No. 1) will authorize and direct the County Controller to place the delinquent trash accounts as a Special Assessment on the Los Angeles County Property Tax Roll. Authorization will ensure payment for delinquent trash charges from Fiscal Year 2025-26, owed to Athens, through the property tax roll, pursuant to the California Government Code Sections 38790.01 and 25831, and Pomona's Municipal Code Section 62-724. Upon receipt and verification of funds from LA County, the City will provide payment to Athens, less the City's administrative charges, for implementing the process.

FISCAL IMPACT:

The City will be reimbursed \$75 per delinquent account to cover the City's administrative costs for assisting Athens Services in the tax roll lien process. Of the \$527,993 in charges to be added to the property tax roll, \$447,518 is the amount of delinquent trash charges and \$80,475 is to be reimbursed to the Refuse Administrative Account FD145 Refuse Admin | CC2506 General Operations | Reimbursement to cover the City's administrative costs.

PREVIOUS RELATED ACTION:

On August 5, 2024, the City Council adopted Resolution 2024-107, approving the submittal of delinquent Solid Waste (Trash) collection accounts to the County Auditor-Controller to be included as a Special Assessment of the property tax roll for FY2024-25

On July 21, 2025, the City Council adopted Resolution 2025-47 authorizing the submittal of delinquent Solid Waste (Trash) collection accounts from FY 2024-25 to the County Controller to be included as a Special Assessment on the FY2025-26 Property Tax Roll.

PUBLIC NOTICING REQUIREMENTS:

Pursuant to Sections 38790.0 and 25831 of the California Government Code, notice of the hearing was mailed to tenants and property owners on June 2, 2026, for the Public Hearing scheduled for July 6, 2026, at the City Council regular meeting, as well as posted by the City Clerk on City designated public notice boards.

DISCUSSION:

In Pomona's Municipal Code Section 62-722 - Billing and Collection (commercial, multifamily, industrial, or institutional) and Section 62-676 - Billing (residential), the franchised hauler has the right to bill and collect fees for such services in advance and shall be directly paid to Athens Services. Per Section 62-724 - Transfer of Delinquent Debt to the City, Athens Services, as the City's franchised hauler, and the designated entity for the collection of fees, is entitled to payment from the owner/occupant for any collection services rendered. If any account holder fails to pay for trash collection services for a 30-day period, the account shall be deemed delinquent, and the hauler shall mail the owner a final request for payment for the amount owed, plus penalties. Code Section 62-275 provides for the City to utilize the lien process to collect the outstanding charges.

In advance of the list presented this evening, there is a collection process with multiple notices. Athens mailed an initial notice on April 5, 2026, to tenants and owners with delinquent accounts from the billing period of March 2025 through February 2026. This notice also advised tenants and property owners of their right to appear before the Public Works Director at an Administrative Hearing to contest the placement of their parcel's delinquent charges on the Property Tax Assessment Rolls. At the time of the initial notice, there were 2,362 delinquent accounts and \$699,450 in outstanding charges.

A second delinquency notice informing property owners and tenants of the Administrative Hearing was mailed on May 15, 2026. The Administrative Hearing took place on May 26, 2026. Athens Services personnel were available to provide account details, receive payments, and make payment arrangements.

A third notice was mailed on June 2, 2026, again advising tenants and property owners of the outstanding charges. The third notice for payment included a notification if the trash collection charges are not paid, the account would be turned over to the City for placement on the property tax roll pursuant to California Government Code Sections 38790.0 and 25831. The notice also informed tenants and property owners of the upcoming hearing at City Council on July 6, 2026, prior to placement on the assessor's tax rolls.

Pursuant to Sections 38790.0 and 25831 of the California Government Code, the final list of delinquent accounts will be assessed to the parcel and collected through the Property Tax Roll upon approval by City Council. The delinquent account list is filed with the City Clerk's Office. The list currently includes 1,073 accounts, totaling \$447,518, in delinquencies for solid waste fees (excluding the City's Administrative fees of \$80,475) as verified by Athens Services and reviewed by the City. The total number of delinquent accounts could change between the time this Staff Report was prepared, and the City Council meeting should additional payments be received.

If approved by the City Council after holding tonight's Public Hearing, the City will be authorized to submit the list of property owners with delinquent charges to the County of Los Angeles Department of Auditor-Controller. The account holders/property owners will have a few extra weeks after the Public Hearing to pay outstanding charges to avoid placement of the lien. The final list of delinquent accounts, not resolved by July 30, 2026, shall be on file with the City Clerk's Office. Such list shall be provided, no later than August 10, 2026, to be included on the County Property Tax Roll for FY 2026-27.
