

RESOLUTION NO. 2026-48

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING THE CITY OF POMONA'S 2025 URBAN WATER MANAGEMENT PLAN: PART 1, PART 2 CHAPTER 4, PART 3, AND PART 4 APPENDIX D

WHEREAS, Article 3 of the California Urban Water Management Planning Act (Act) requires every urban water supplier prepare and adopt an Urban Water Management Plan (UWMP);

WHEREAS, the City Council desires to comply with the Act, which requires an update of the plan once every five (5) years;

WHEREAS, prior to approving its UWMP, the City must conduct a public hearing, noticed in accordance with California Government Code Section 6066;

WHEREAS, on March 18, 2026, a notice was sent to cities, the county, and water agencies that utilize Pomona water that the 2025 UWMP update was being prepared; and a Public Hearing for the 2025 UWMP was scheduled for May 18, 2026;

WHEREAS, a copy of the draft 2025 UWMP update was placed on file in the City Clerk's Office for public review;

WHEREAS, pursuant to California Water Code Section 10642, the notice of the Public Hearing was published in the Inland Valley Daily Bulletin on May 4, 2026, and May 11, 2026; and

WHEREAS, the City Council has conducted a duly noticed public hearing in accordance with the provisions set forth in Article 3 of the Act; and wishes to adopt the 2025 UWMP update.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby accepts and approves Part 1, Part 2 Chapter 4, Part 3, and Part 4 Appendix D within the attached UWMP (Exhibit A).

SECTION 2. Upon the passage of this resolution, City staff is hereby directed send a copy of this resolution and the City's approved 2025 UWMP to the State Water Resources Control Board.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective upon its approval.
