**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, TO AMEND THE FY 2025-26 CAPITAL IMPROVEMENT PROGRAM BUDGET BY UNAPPROPRIATING \$50,000 OF PREVIOUSLY APPROPRIATED GENERAL FUNDS FROM “PD ROOF DRAINAGE MODIFICATIONS,” FD428 | CC2590 CAPITAL IMPROVEMENT PROGRAM (CIP) | WORKTAG: PROJECT 71115 AND REAPPROPRIATING THESE GENERAL FUNDS TO “FOURTH STREET PD EVIDENCE BUILDING ROOF STRUCTURE REHABILITATION,” FD428 | CC2590 CAPITAL IMPROVEMENT PROGRAM (CIP) | WORKTAG: PROJECT 71123**

**WHEREAS**, the City Council of the City of Pomona adopts an annual Capital Improvement Program (CIP) budget to fund public infrastructure and facility improvements;

**WHEREAS**, the FY 2025-26 CIP budget includes funding for the “PD Roof Drainage Modifications,” project FD428 | CC2590 Capital Improvement Program (CIP) | Worktag: Project 71115;

**WHEREAS**, additional funding is needed for the “Fourth Street PD Evidence Building Roof Structure Rehabilitation” project FD428 | CC2590 Capital Improvement Program (CIP) | Worktag: Project 71123 to support contingency and staff time;

**WHEREAS**, the City Council wishes to amend the FY 2025-26 Capital Improvement Program (CIP) budget by unappropriating and reappropriating \$50,000 of previously appropriated General funds from “PD Roof Drainage Modifications,” FD428 | CC2590 Capital Improvement Program (CIP) | Worktag: Project 71115 to “Fourth Street PD Evidence Building Roof Structure Rehabilitation,” FD428 | CC2590 Capital Improvement Program (CIP) | Worktag: Project 71123 in order to provide funding for contingency and staff time.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council amends the FY 2025-26 CIP Budget by unappropriating \$50,000 of General funds from “PD Roof Drainage Modifications,” FD428 (CIP) | CC2590 Capital Improvement Program (CIP) | Worktag: Project 71115 and reappropriating \$50,000 of General funds to “Fourth Street PD Evidence Building Roof Structure Rehabilitation,” FD428 | CC2590 Capital Improvement Program (CIP) | Worktag: Project 71123.

**SECTION 2.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
