This Amendment No. 1 (“Amendment”) to the underlying Memorandum of Understanding No. (M-015-26) (“MOU”) is by and between the **SOUTHERN CALIFORNIA ASSOCIATION OF GOVERNMENTS** (“SCAG”) and the **CITY OF POMONA**, subsequently herein referred to as the “PROJECT PARTICIPANT,” for the **City of Pomona Complete Streets Ordinance and Quick Build Project** (“Project”). SCAG and the PROJECT PARTICIPANT are individually referred to herein as “Party” and may be collectively referred to herein as “Parties.”

RECITALS

WHEREAS, the Parties entered into the MOU dated 12/17/2025; and

WHEREAS, Section 10 of the MOU permits the Parties to amend the MOU through written amendment; and

WHEREAS, the purpose of Amendment No. 1 (“Amendment 1”) is to update the subaward period of performance end date and MOU amount.

NOW THEREFORE, IT IS MUTUALLY AGREED THAT:

1. Section 2. Term is amended to read:

The Term of this MOU shall begin on the Effective Date of the MOU and continue until December 13, 2026, hereinafter referred to as the “Completion Date,” unless terminated earlier as provided herein. Time is of the essence in the performance of services under this MOU.

2. Section 5. Funding is amended to read:

- a. SCAG’s contribution to the Project is funded wholly with ATP State grant funds (non-federal), in an amount not to exceed One-Hundred Ninety-Three Thousand, Three Hundred Seventeen Dollars (\$193,307) for the quick build construction phase. SCAG shall not be obligated to make payments for any Work costs that exceed \$193,307. SCAG shall not be obligated to pay for any increase in Work costs which exceeds SCAG’s obligated funding amount. SCAG shall not be obligated to make payments from any source other than funds provided by ATP to SCAG pursuant to the ATP state grant.

- b. All obligations of SCAG under this MOU are subject to the availability of State funds and enactment of the State of California (“State”) Budget Act. Thus, no payments may be made under this MOU prior to the passage of the State Budget Act for any Fiscal Year.
- c. During the technical assistance phase, no funds shall be paid directly to CITY, funds shall only be paid to SCAG Consultant. During the quick build phase, funds may be paid directly to CITY, which is not to exceed \$193,307.

In all other respects, the terms and conditions of the MOU, as amended, shall remain in full force and effect.
