RESOLUTION NO. 2026 – 51 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA AMENDING THE FY 2025-26 OPERATING BUDGET BY ACCEPTING AND INCREASING REVENUE ESTIMATES BY \$500,000 OF MEASURE A GRANT FUNDING FROM LOS ANGELES COUNTY’S REGIONAL PARK AND OPEN SPACE DISTRICT AND AMENDING THE FY 2026-27 CAPITAL IMPROVEMENT PROGRAM (CIP) BY CHANGING THE TITLE OF THE “PALM LAKE GOLF COURSE MASTER PLAN” WORKTAG: PRJ-00013 FD428-CC2590-GR-000016, A NEW CIP PROJECT CREATED WITH THE ADOPTION OF THE FY 2026-27 CIP BUDGET TO “PALM LAKE GOLF COURSE REVITALIZATION,” WORKTAG: PRJ-00013- FD428-CC2590- -GR-000016;

WHEREAS, the Los Angeles County Regional Park and Open Space District administers Measure A grant funds for projects that improve parks, recreation, open space, trails, and recreational opportunities throughout Los Angeles County;

WHEREAS, the City of Pomona recognizes the importance of providing safe, accessible, and high-quality parks and recreational amenities for residents of all ages and abilities;

WHEREAS, the City submitted an application to the Los Angeles County Regional Park and Open Space District for Measure A grant funding for the Palm Lake Revitalization Project;

WHEREAS, the Los Angeles County Regional Park and Open Space District has awarded Measure A funds to the City of Pomona for the Project;

WHEREAS, the Project will provide planning and design services for the Palm Lake Revitalization Project, including community engagement, conceptual development, and preparation of construction documents to improve public access;

WHEREAS, the City Council desires to accept the awarded Measure A grant funds and authorize the execution of all required agreements and documents necessary to implement the Project; and

WHEREAS, the City Council desires to amend the FY 2026-27 CIP Budget by changing the project title for newly created CIP project, “Palm Lake Golf Course Master Plan,” Project No. FD428-CC2590-PRJ-00013 to “Palm Lake Golf Course Revitalization,” Project No. FD428-CC2590-PRJ-00013.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby accepts the Measure A grant award from the Los Angeles County Regional Park and Open Space District in the amount of \$500,000 for the Palm Lake Revitalization Project.

SECTION 2. The City Council amends the FY 2025-26 Operating Budget by increasing grant revenue estimates (FD215-CC4190- RC188 Measure A Revenue-GR-000016) in the amount of \$500,000 for the Palm Lake Revitalization Project.

SECTION 3. . The City Council amends the FY 2026-27 CIP Budget by changing project name from, “Palm Lake Golf Course Master Plan,”, Project No. FD428-CC2590-PRJ-00013 to “Palm Lake Golf Course Revitalization,”, Project No. FD428-CC2590-PRJ-00013.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval
