A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2026-27 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES IN THE AMOUNT OF \$205,000 IN FD215 GRANT – MISCELLANEOUS | CC2520 STREET MAINTENANCE | GRANT – STATE | GR-000015, CLEAN CALIFORNIA LOCAL GRANT AND CORRESPONDING APPROPRIATIONS IN FD215, GRANT – MISCELLANEOUS | CC2520, STREET MAINTENANCE | CONTROLLABLE CONTRACT SERVICES | GR-000015, CLEAN CALIFORNIA LOCAL GRANT FOR BEAUTIFICATION AND WORKFORCE DEVELOPMENT WORK AS PART OF THE CALIFORNIA DEPARTMENT OF TRANSPORTATION (CALTRANS) CLEAN CALIFORNIA GRANT PROGRAM

WHEREAS, the City of Pomona has been awarded a \$205,000 restricted grant by the State of California Department of Transportation (Caltrans); and

WHEREAS, the authority to amend the FY 2026-27 Operating Budget in the amount of \$205,000 for waste reduction and beautification within public rights-of-way, tribal lands, parks, pathways, transit centers and other public spaces and accept grant funding award is vested with the City Council;

WHEREAS, the restricted grant agreement is to provide funding and resources to support local waste reduction and enhance, rehabilitate, restore, or install measures to beautify and improve public spaces.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby amends the FY 2026-27 Operating Budget by increasing revenue estimates in the amount of \$205,000 in FD215, Grant- Miscellaneous | CC2520, Street Maintenance | Grant-State | GR-000015, Clean California Local Grant and corresponding appropriations in FD215, Grant - Miscellaneous | CC2520, Street Maintenance | Controllable Contract Services | GR-000015, Clean California Local Grant for beautification and workforce development work as part of the California Department of Transportation (Caltrans) Clean California Program.

SECTION 2. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
